

## The fallacy of the British Government protecting Muslims born in the UK

Ever wondered why the British government had refused to help Muslims held by the Yemen authorities under terrorist charges?

Take as a case study, recently a British born woman who worked as a Japanese waitress and had gone missing for a mere 24hrs! Not only did the British foreign minister contact the Japanese ambassador but made it clear to the Japanese authorities that an investigation was needed to find this British woman and that it was of high priority.

In contrast to this, in the past our Khaleefah used to be our shield, protecting Muslims worldwide, today Muslims don't have any Khaleefah and rely on prime ministers who really don't give a toss about Muslims. They only do as they are told by Britain (Whitehall) and that leaves the Muslims open to abuse even in the Muslim countries.

Lets refer to some statistics:

Current statistics on people (university lecturers, school teachers, doctors, students, policemen, army personnel, civilians, opposition groups, philosophers, Imams of mosques, scholars, postmen, etc.. ) jailed for demanding a political change from democracy to Islam is shown below:

Saudi Arabia	18,000
Syria	38,000
Egypt	25,000
Jordan	10,000

These Muslims are detained indefinitely and without any human rights. It is reported that these prisoners are routinely tortured both physically and mentally. In Saudi Arabia, prisoners are raped, sexually abused and electrical current is passed through their sexual organs.

Only recently, over 15,000 people, mostly consisting of whole families were detained in appalling conditions in South Lebanon and had to physically break out as the Israeli forces were killing Muslims as they withdrew in humiliation.

Muslims in Europe (inc. Britain) are provided jobs, motivated by acquiring wealth and climbing the corporate ladder while their children are indoctrinated by secular concepts from any early age, that devoids them of any Islamic personality, becoming docile and refrain from making any effort to learn about political Islam later on life, which by that time Islam is like any other religion. The following extracts highlight the dangerous times that Muslims live in as the western governments begin to close in their net and soon we may find ourselves part of a global conspiracy that we thought would not have been possible here in Britain. Wake up Muslims before its too late!

## **Muslims deported for death sentencing for having political views**

Friday the 21st of May 2000 marks another tragic day in the history of Britain's relationship with Muslims. It is the day when six innocent Muslims are due to be deported to Egypt and Algeria where they face the very real possibility of execution by their corrupt and brutal regimes. Those due to be extradited include: Mr Hani Sibaie, Mr Ibraheem Al-Ai'darous, Mr Osama Hsan, Mr Sayed Ahmed and Mr Sayed Mu'awadh all Egyptian refugees and Mr Rasheed Ramda an Algerian refugee. The British government have been holding the six since around September 1998 and "Operation Challenge", a brutal campaign against Muslims orchestrated by MI5 and Special Branch which sparked a strong backlash from the Muslim community against the then new draconian measures introduced by the government intended to silence Islamists and to stamp out their activities.

These deportations have again highlighted the nature and reality of the crusade launched against Islam and Muslims in the name of pejorative such as 'terrorism', 'militants' and 'fundamentalists' though specifically targeting the peaceful activities of Islamic movements. Clearly a firm and brutal message is intended to go out to all activists challenging them to either remain silent or face similar harassment. The government's real intention has always been to subdue Muslims from speaking out against oppression and corruption manifest both here in Britain and in Muslim Countries from the implementation, by both them and their so-called 'friends', of their fascist man-made law. Lest these Muslims effect Britain's economic, military or political interests in those countries, the institutionalized racism within the British establishment has instead sought to victimize them.

It is clear that Tony Blair and his Labour government, despite its show of tolerance and racial harmony in its recent meeting with the unrepresentative Muslim Council of Britain, has adopted a harsh policy against the peaceful Muslim community using fear, force and the method of tyrant regimes such as Saudi Arabia, Egypt, Iraq, Algeria, Syria, Iran and other Middle-eastern governments in exchange for future economic favours from them. However the price which will need to be paid is not only the peaceful activities and security of some political refugees but that of an already angry Muslim community who are now not only finding their brothers and sisters being murdered every day by this government in Iraq but that they are also now sending innocent Muslims abroad to an almost inevitable fate of death at the hands of vicious dictatorial regimes.

Muslims in Britain had demonstrated on Friday the 21st of May against the aggression of this British Government. By mobilizing the Muslim community to create public opinion against such prejudice and so to apply pressure on the establishment to avoid further harassment and arrests and the immediate provision of sanctuary for those due to be extradited. Muslims everywhere should know not to be betrayed into believing that Britain is a haven where they can seek asylum rather they should be aware that political asylum in Britain means that they are required to compromise their Islamic beliefs and to remain silent about atrocities committed against Muslims around in the world.

In response to the current crisis Mr Abdul Rahman Saleem, The Spokesman of Al-Muhajiroun in the UK said: "The continued custody of these Muslims since last September and the continual bombing of Iraq is a challenge and humiliation for Muslims"

Mr Anjem Choudary, The Secretary general of The Society of Muslim Lawyers said: "We call for the immediate release of these six Muslims together with a full apology and compensation and an immediate cessation of hostilities against Muslims in Iraq"

Sheikh Omar Bakri Muhammad, The Judge of the Shari'ah Court of the UK said: "The inhuman treatment of these Muslims who are seeking refuge to protect their lives from illegitimate death sentences shows us the extent of the decline in Christian values when compared to the Christians of the past. The Abyssinian Christians granted the Muslims at the time of the Messenger Muhammad (saw) complete protection and even fought against their

opposition to ensure that their safety was ensured." Sheikh Omar warned the government "We hold this government responsible for the safety of these brothers and warn of the potential consequences for Britain's national security because of their governments constant aggression against Muslims "

## **The Islamic Khilafah is the protector of the Muslim countries. It's establishment is fard, and neglecting to work for it is haram**

The Khilafah is the general leadership of all the Muslims in the whole world, to implement the Islamic Shari'a laws, and to carry the Islamic da'wa to the world. It is the political entity which brings the Muslims together and unites their lands. The Messenger of Allah (saw) has ordered the Muslims to have one Khaleefah who will rule them with the Islamic Shari'a. It has been reported in Sahih Muslim that the Messenger of Allah (saw) said: "...there will be Khulafaa who will number many". They asked: 'Then what do you order us to do?' He (saw) said: "Give allegiance (bay'a) to them one after another". And he (saw) said: "If the bay'a has been given to two Khulafaa, kill the latter of them." The Khilafah is the state about whose return the Messenger of Allah (saw) has given us glad tidings when he said: "...then there will be a Khulafaa on the way of Prophethood."

The Khilafah is the state which will apply on the Muslims what Allah has made obligatory from the Islamic Shari'a rules regarding judiciary, ruling, economy, social aspect, education and foreign policy.

The Khilafah is the Islamic state which will apply what Allah has made obligatory in terms of undertaking Jihad to carry the Islamic Message to the world and protecting the land of the Muslims and defending their blood, honour, property and those that are under their protection (Dhimma).

It is the state which will prohibit the munkar from which the Muslims have been ordered to refrain. And it will eliminate all forms of corruption in society and protect the creed. Thus, it will prevent any deviation from the creed and any slander or attack made against it.

The Khilafah will spread the atmosphere of Iman, purity and noble morals in all sectors of society, in the media, educational institutes and organisations. The citizens of the Islamic state will not fear for their sons and daughters being swept away by calls to munkar, corruption and moral degeneration.

The Khilafah will undertake what the Muslims have been ordered to do in terms of getting rid of enmity and hostility between Muslims and distancing them from any form of partisanship or tribalism. The state does not belong to a faction or mazhab, rather it has one outlook towards its citizens. It implements the rules of Islam upon them according to the strongest evidence in the Kitab and Sunnah.

It is not a state based on a race or colour. An Arab is not superior to a non-Arab and nor is a white person superior to a black person except by Taqwa (the fear of Allah).

Each Muslim should be concerned about all of the rules of Islam, because he has been addressed by them. And he should be concerned about all Muslims in the world and he has been ordered to have this concern for them. Allah ta'ala said: "The believers are nothing else than brothers" [49:10]

And He (saw) said: 'The similitude of the believers in their love for each other, and the mercy they have for each other and the kindness they show to each other is that of one body which when one of its limbs hurts then the entire body responds to that part with sleeplessness and fever.'

The Islamic Khilafah is the state of all Muslims. It is their demand and an obligation on their necks. In Sahih Muslim it has been reported that the Messenger of Allah (saw) said: "whosoever dies without an oath of allegiance (bay'a) on his neck, he will die the death of Jahiliyya." Thus, the Muslim in America is like the Muslim in Europe. And the Muslim in China is like the Muslim in Indonesia and the Muslim in Lebanon is like the Muslim in Morocco. All of them are ordered to adhere to the rules of Islam and it is obligatory on them to establish the Islamic Khilafah.

Every Muslim should have firm conviction that he belongs to the one Muslim Ummah, and that it is not allowed for the Muslims to remain divided and weak in the countries created, and imposed on them by colonialism. Rather, they should gain awareness and work to merge these artificial entities into one state. Therefore, the Muslim in Egypt should call for the Islamic Khilafah and work for it, so that Egypt can be part of the Islamic Khilafah. Likewise, the Muslim in Kuwait should call for Kuwait to be part of the Islamic Khilafah. And the same should take place in Sudan, Pakistan, Iraq, Iran, Syria, Lebanon and the rest of the Muslim countries.

The Islamic Khilafah is not a state which looks after the affairs of Muslims only, rather it will look after the affairs of anyone who carries the citizenship of the Islamic state, whether he be a Muslim or a non-Muslim. He has the right to complete protection, enjoying legal rights and obligations. There is no discrimination in terms of the judiciary or the looking after of affairs. The blood, property, and honour of non-Muslims is preserved and protected.

The Muslim knows that truth and falsehood do not meet, and that Kufr and Iman cannot co-exist. And he knows his call for the unification of Islamic lands and application of Islam will be countered and fought by the Kuffar and their agents. Hence, the Messenger (saw) and those with him, did not find any acceptance or welcome from the Kuffar. On the contrary, they found unsheathed swords and angry hearts. And hence the great Islamic battles took place and victory was for Islam. This is a fact Allah has informed us about in His Noble Kitab: He (swt) said:

"They had nothing against them, except that they believed in Allah, the All-Mighty, Worthy of all Praise!" [85:8]

And He (swt) said: "Verily, those who disbelieve spend their wealth to hinder (men) from the Path of Allah" [8:36]

And He (swt) said: "And they will never cease fighting you until they turn your back from your deen if they can" [2:217]

And here is the test for the Muslim. Either he calls to that which Allah has ordered him and patiently bears the trial and tribulation and (he believes) Allah is his Helper. Or he neglects what Allah has obliged on him and accordingly earns Allah's anger and displeasure and falls prey to the machinations of the oppressors and kuffar whose mind will find no rest as long as there is a Muslim entity. Like the Muslims of Kosovo and Bosnia how their submission did not intercede for them, rather a war of annihilation was launched against them in the Balkans. What has happened or is happening in Palestine, Kashmir, Chechnya, and Iraq, are but live examples of what affliction and hardship the Muslims have come to expect, when they do not embark on taking their affairs into their own hands to thwart any affliction before it moves against them.

The Muslim Ummah everywhere knows that her liberation will be through Islam and through its rule. And she knows that her rulers have misled and failed her. And she knows that she

occupies an important strategic area, containing vast natural resources, and that she forms a quarter of the inhabitants on earth. The Ummah has to decide on taking matters into her own hands. And put her reliance in Allah as He (swt) has ordered, deriving her strength from Him (swt), and having confidence that He is the One Who gives honour and dignity (Mu'iz) and He is the One Who brings disgrace and humiliation (Muzil). Then by the determination of her sons and the support of the sincere people of power in her lands. And while reciting the saying of Allah (swt):

"How often a small group overcame a mighty host by Allah's Leave?" [2:249]

And His (swt) saying: "Allah loves those who put their trust (in Him)" [3:159]

And His saying: "Whosoever desires honour, power and glory then to Allah belongs all honour, power and glory" [35:10]

Then, after this, she acts wisely using the experience of the sincere politicians at her disposal, combining strength, politics and planning. She then builds her industry, gains awareness of the current international situation and balance of power. Then, she should act in a manner that will bring her success and continuity, and oppose, with the strength of her creed and the determination of her people, every aggression, striving with heart and soul, for supporting the deen and protecting the Muslim lands. Then, with the permission of Allah, will the Ummah prevail over her enemy, and that day the believers will rejoice for the victory of Allah. And that is not hard for Allah (swt).

O Muslims. Indeed Allah has honoured us with Islam and gave power and glory ('izza) through it. He (swt) said:

"But honour, power and glory belong to Allah, His Messenger (saw), and to the believers"[63:8]

So hasten towards the work with which Allah and His Messenger (saw) are pleased, and work with those who are working to implement Allah's command to establish the righteous Islamic Khilafah on the way of the Prophethood, so that you may attain the good of this dunya and the Akhira.

## **Britain strikes at freedom on the Net**

On Monday the Irish e-commerce Bill became law. Section 28 of it says: "Nothing in this Act shall be construed as requiring the disclosure or enabling the seizure of unique data, such as codes, passwords, algorithms, private cryptographic keys, or other data, that may be necessary to render information or an electronic communication intelligible."

On Thursday, the British Regulation of Investigatory Powers (RIP) Bill completed its passage through the Lords, on its way to the Statute Book in October. Although their Lordships have done some sterling work in Committee, the Bill that now returns to the Lower House preserves intact its sinister essence as a spooks' charter.

The RIP Bill still makes it a criminal offence, punishable by five years in prison, to tell anyone (including a client, an employer or your family) that you have been served with an order to surrender encryption keys, or that you have been forced to hand over encrypted material in plain text form.

It still provides for the installation of remote-controlled boxes in an internet service provider's premises which relay all data passing through the ISP to a special monitoring centre at security services MI5.

It still gives the security services power to monitor - without a warrant - the e-mail addresses of everyone with whom you communicate. And, through a strange conjunction of internet technology and a legal loophole, it extends GCHQ's existing powers to trawl through all external communications to and from the UK to cover internal data traffic. (Users of Hotmail and other email services hosted in the US, please note.)

The RIP Bill is a catastrophe on two fronts. First, it makes colossal and essentially unsupervised inroads into civil liberties. >From October, nobody in the UK can feel confident that their internet use is not being trawled or intercepted by the Minister of the Interior or his goons.

Second, it makes it a racing certainty that the UK will miss out on the coming e-business revolution.

What British Home Secretary Jack Straw et al clearly do not understand is that encryption is the core technology of e-business, and that internet commerce only works if businesses and customers are completely confident that their encryption methods are secure.

It is clear from their private and public reactions that major e-business companies and industrial lobbies see the RIP Bill as undermining that security. They are entirely unimpressed by the assurances of Charles Clarke and other Home Office Ministers that its sweeping powers will be exercised "reasonably".

"The only thing I care about," the security manager of a major bank is reported to have said to Clarke in a private meeting, "is the text of the Act. Which is why my [encryption] keys are going to Switzerland." What the RIP fiasco also demonstrates is how Blair's goofy pledge to make the UK "the most e-friendly country in the world" was really just a sound-bite masquerading as policy.

If the Prime Minister really wants to see what a serious e-friendly strategy looks like, all he has to do is take a trip to Dublin. Ireland was the first country to use a digital signature to sign an inter-governmental agreement (on 7 September 1998).

They've set up a development fund to help small and medium-sized Irish enterprises switch to e-commerce. I could go on, but you get the point. So do British ISPs, three of which announced last week that they will set up offshore operations if the RIP Bill is passed. Another triumph for New Labour. Source: The Observer News Service
